

## Senate Resolution 301

**ADOPTED SENATE**

## A RESOLUTION

- 1 Creating the Senate Rosenwald Schools Study Committee; and for other purposes.
- 2 WHEREAS, in the early 1900s, Julius Rosenwald, one of the early presidents and part owner  
3 of Sears, Roebuck and Co., partnered with Booker T. Washington, a Black educator and  
4 leader, to fund construction of schools in poor, rural African American school districts across  
5 the South; and
- 6 WHEREAS, Rosenwald schools were cooperatively built with donations of land and labor  
7 from the local communities and matching financial contributions from the Rosenwald  
8 Foundation; and
- 9 WHEREAS, the foundation helped fund the construction of almost 5,000 schools for Black  
10 children around the South, which helped lift generations of African Americans out of  
11 poverty; and
- 12 WHEREAS, the program provided funding for more than 240 Rosenwald schools in 103 of  
13 Georgia's 159 counties, and at least 35,000 children attended those schools; and

14 WHEREAS, school integration brought an end to operation of the Rosenwald schools,  
15 though many continued to serve their communities long after; and

16 WHEREAS, Rosenwald and Washington's program dramatically transformed the country  
17 by profoundly reshaping the African American experience, yet its scope and impact are  
18 largely unknown and remain hidden history; and

19 WHEREAS, the history of Rosenwald schools in Georgia and their impact on the education  
20 and economic prosperity of African Americans in the state is deserving of study.

21 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:

22 (1) **Creation of Senate study committee.** There is created the Senate Rosenwald  
23 Schools Study Committee.

24 (2) **Members and officers.** The committee shall be composed of five members of the  
25 Senate to be appointed by the President of the Senate. The President shall designate a  
26 member of the committee as chairperson of the committee.

27 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,  
28 issues, and problems mentioned above or related thereto and recommend any action or  
29 legislation which the committee deems necessary or appropriate.

30 (4) **Meetings.** The chairperson shall call all meetings of the committee. The committee  
31 may conduct such meetings at such places and at such times as it may deem necessary or  
32 convenient to enable it to exercise fully and effectively its powers, perform its duties, and  
33 accomplish the objectives and purposes of this resolution.

34 (5) **Allowances and funding.**

35 The legislative members of the committee shall receive the allowances provided for in  
36 Code Section 28-1-8 of the Official Code of Georgia Annotated. The allowances  
37 authorized by this resolution shall not be received by any member of the committee for

38 more than five days unless additional days are authorized. Funds necessary to carry out  
39 the provisions of this resolution shall come from funds appropriated to the Senate.

40 **(6) Report.**

41 (A) In the event the committee adopts any specific findings or recommendations that  
42 include suggestions for proposed legislation, the chairperson shall file a report of the  
43 same prior to the date of abolishment specified in this resolution, subject to  
44 subparagraph (C) of this paragraph.

45 (B) In the event the committee adopts a report that does not include suggestions for  
46 proposed legislation, the chairperson shall file the report subject to subparagraph (C)  
47 of this paragraph.

48 (C) No report shall be filed unless the same has been approved prior to the date of  
49 abolishment specified in this resolution by majority vote of a quorum of the committee.  
50 A report so approved shall be signed by the chairperson of the committee and filed with  
51 the Secretary of the Senate.

52 (D) In the absence of an approved report, the chairperson may file with the Secretary  
53 of the Senate a copy of the minutes of the meetings of the committee in lieu thereof.

54 **(7) Abolishment.** The committee shall stand abolished on December 1, 2025.
