A BILL FOR AN ACT ENTITLED: "AN ACT CREATING A CIRCUIT BREAKER INCOME TAX CREDIT FOR PROPERTY TAXES PAID AND RENT-EQUIVALENT PROPERTY TAXES PAID; ~~REPEALING THE PROPERTY TAX ASSISTANCE PROGRAM FOR FIXED OR LIMITED INCOME, THE DISABLED VETERAN PROGRAM, THE RESIDENTIAL PROPERTY TAX CREDIT FOR THE ELDERLY, AND THE INTANGIBLE LAND VALUE PROPERTY EXEMPTION; PROVIDING THAT A TAXPAYER MAY CLAIM EITHER THE CIRCUIT BREAKER TAX CREDIT OR THE RESIDENTIAL PROPERTY TAX CREDIT FOR THE ELDERLY AND PARTICIPATE IN THE PROPERTY TAX ASSISTANCE PROGRAM OR THE DISABLED VETERAN ASSISTANCE PROGRAM OR RECEIVE THE INTANGIBLE LAND VALUE PROPERTY EXEMPTION;~~ PROVIDING DEFINITIONS; AMENDING SECTIONS ~~15-6-201, 15-6-240, 15-6-302, 15-7-102, 15-16-101, 15-16-102, 15-17-125, 15-18-112, 15-30-2303, 15-30-2338, AND 53-4-1103~~ 15-30-2341, MCA; ~~REPEALING SECTIONS 15-6-240, 15-6-301, 15-6-302, 15-6-305, 15-6-311, 15-6-312, 15-30-2337, 15-30-2338, 15-30-2339, 15-30-2340, AND 15-30-2341, MCA;~~ AND PROVIDING A DELAYED EFFECTIVE DATES DATE AND AN APPLICABILITY DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Property tax and rent-equivalent property tax circuit breaker credit - definitions. As used in [sections 1 through 4], the following definitions apply:

- (1) "Claim period" means the tax year for claimants required to file a Montana tax return or returns under chapter 30 and the calendar year for claimants not required to file returns.
- (2) "Claimant" means a person who is eligible to file a claim for a credit under [sections 1 through 4].
- (3) "Gross rent" means the total rent in cash or its equivalent actually paid during the claim period

1 by the renter or lessee for the right of occupancy of the qualified rental residence pursuant to an arm's-length
2 transaction with the landlord.

3 (4) (a) "Household" means an association of persons who live in the same dwelling, sharing its
4 furnishings, facilities, accommodations, and expenses.

5 (b) The term does not include bona fide lessees, tenants, or roomers and boarders on contract.

6 (5) "Household income" means all income received by all persons of a household in a tax year
7 while they are members of the household.

8 (6) (a) "Income" means, except as provided in subsection (6)(b), federal adjusted gross income,
9 without regard to loss, as that quantity is defined in the Internal Revenue Code, plus all nontaxable income,
10 including but not limited to:

11 (i) the amount of any pension or annuity, including Railroad Retirement Act benefits and veterans'
12 disability benefits;

13 (ii) the amount of capital gains excluded from adjusted gross income;

14 (iii) alimony;

15 (iv) support money;

16 (v) nontaxable strike benefits;

17 (vi) cash public assistance and relief;

18 (vii) interest on federal, state, county, and municipal bonds; and

19 (viii) all payments received under federal social security except social security income paid directly
20 to a nursing home.

21 (b) For the purposes of this subsection (6), income is reduced by the taxpayer's basis.

22 (7) "Property tax billed" means taxes levied against the qualified residence, including special
23 assessments and fees but excluding penalties or interest during the claim period.

24 (8) (a) (i) "Qualified rental residence" means any class four residential dwelling that is a single-
25 family dwelling unit, unit of a multiple-unit dwelling, trailer, manufactured home, or mobile home that is rented
26 from a third party, located in Montana, and subject to property taxes and as much of the surrounding land, not
27 exceeding 1 acre, as is reasonably necessary for its use as a dwelling.

28 (ii) The term includes a single-family dwelling unit or unit of a multiple-unit dwelling that is rented

1 from a county or municipal housing authority as provided in Title 7, chapter 15.

2 (b) Except for dwellings rented from a county or municipal housing authority, the term does not
3 include rented dwellings or rented lands that are not subject to Montana property taxes during the claim period.

4 (9) "Qualified residence" means any owner-occupied class four residential dwelling that is a single-
5 family dwelling unit, unit of a multiple-unit dwelling, trailer, manufactured home, or mobile home located in
6 Montana that is subject to property taxes and as much of the surrounding land, not exceeding 1 acre, as is
7 reasonably necessary for its use as a dwelling.

8 (10) "Rent-equivalent property tax paid" means 15% of gross rent.

9 (11) "Tax year" means the property tax year preceding the current year in which a claim for a
10 property tax circuit breaker credit is made.

11 (12) "Threshold amount" means the amount determined based on household income as follows:

12 (a) on the first \$20,000 of household income, 1%;

13 (b) on \$20,001 to \$40,000 of household income, 2.5%;

14 (c) on \$40,001 to \$60,000 of household income, 3.5%;

15 (d) on \$60,001 to \$80,000 of household income, 5.5%;

16 (e) on \$80,001 to \$100,000 of household income, 7.5%;

17 (f) on household income above \$100,000, 9.5%.

18

19 **NEW SECTION. Section 2. Property tax and rent-equivalent property tax circuit breaker credit -**

20 **- eligibility.** (1) In order to make a claim for a credit under [sections 1 through 4], the individual must have:

21 (a) resided in Montana for at least 9 months of the tax year for which the claim is made; ~~and~~

22 (b) occupied one or more qualified residences as an owner or one or more qualified rental

23 residences as a renter or lessee for at least 6 months of the tax year; AND

24 (C) HOUSEHOLD INCOME OF LESS THAN \$130,000.

25 (2) A person is not disqualified from claiming the credit under [sections 1 through 4] because of a

26 change of residence during the claim period if the person occupies a qualified residence as an owner or a

27 qualified rental residence as a renter or lessee in Montana for at least 7 months during the claim period.

28 (3) A TAXPAYER MAY NOT CLAIM THE CREDIT PROVIDED FOR IN [SECTIONS 1 THROUGH 4] AND THE

1 RESIDENTIAL PROPERTY TAX CREDIT FOR THE ELDERLY PROVIDED FOR IN 15-30-2337 THROUGH 15-30-2341.

2 (4) Only one claim for a property tax circuit breaker credit OR THE RESIDENTIAL PROPERTY TAX
3 CREDIT FOR THE ELDERLY PROVIDED FOR IN 15-60-2337 THROUGH 15-30-2341 may be made with respect to any
4 qualified residence.

5 (5) A claim for the credit may not be allowed for any portion of property tax billed or rent-equivalent
6 property tax paid that is derived from a public tax subsidy program or a public rent subsidy program.

7 (6) A claim is disallowed if the department finds that the claimant received title to the claimant's
8 qualified residence primarily for the purpose of receiving benefits under [sections 1 through 4].

9 (7) When the landlord and tenant have not dealt at arm's length and the department judges the
10 gross rent charged to be excessive, the department may adjust the amount considered gross rent to a
11 reasonable amount.

12

13 NEW SECTION. Section 3. Property tax and rent-equivalent property tax circuit breaker credit -

14 **- credit amount.** (1) There is a credit against the taxes imposed by this chapter for a portion of property tax
15 billed or rent-equivalent property tax paid by a claimant in the tax year as provided in this section.

16 (2) The amount of the credit allowed under this section is equal to the property tax billed or rent-
17 equivalent property tax paid in the tax year times 0.75 minus the threshold amount.

18 (3) If the amount determined is equal to or less than zero, there is no credit.

19 (4) If two or more individuals share a qualified rental residence, each individual may claim the
20 credit based on the proportional share that the individual pays of the gross rent.

21 (5) If the amount of the credit exceeds the claimant's liability under this chapter, the amount of the
22 excess must be refunded to the claimant. The credit may be claimed even though the claimant has no taxable
23 income under this chapter.

24

25 NEW SECTION. Section 4. Property tax and rent-equivalent property tax circuit breaker credit -

26 **- filing date -- denial of claim.** (1) Except as provided in subsection (3), a claim for the credit must be
27 submitted at the same time the claimant's tax return is due under chapter 30. For an individual not required to
28 file a tax return, the claim must be submitted on or before April 15 of the year following the year for which the

1 credit is sought.

2 (2) A receipt showing property taxes billed or gross rent paid must be filed with each claim. Each
3 claimant shall, at the request of the department, supply all additional information necessary to support a claim.

4 (3) The department may grant a reasonable extension for filing a claim whenever, in its judgment,
5 good cause exists.

6 (4) If an individual who would have a claim under [sections 1 through 4] dies before filing the claim,
7 the personal representative of the estate of the decedent may file the claim.

8 (5) The department or an individual may revise a return and make a claim under [sections 1
9 through 4] within 3 years from the last day prescribed for filing a claim for relief.

10 (6) A person filing a false or fraudulent claim under the provisions of [sections 1 through 4] must be
11 charged with the offense of unsworn falsification to authorities pursuant to 45-7-203. If a false or fraudulent
12 claim has been paid, the amount paid, penalties, and interest may be recovered as provided in 15-1-216.

14 **Section 5.** Section 15-6-201, MCA, is amended to read:

15 ~~"15-6-201. Governmental, charitable, and educational categories -- exempt property.~~ (1) The
16 following categories of property are exempt from taxation:

17 (a) ~~except as provided in 15-24-1203, the property of:~~

18 (i) ~~the United States, except:~~

19 (A) ~~if congress passes legislation that allows the state to tax property owned by the federal
20 government or an agency created by congress; or~~

21 (B) ~~as provided in 15-24-1103 ;~~

22 (ii) ~~the state, counties, cities, towns, and school districts;~~

23 (iii) ~~irrigation districts organized under the laws of Montana and not operated for gain or profit;~~

24 (iv) ~~municipal corporations;~~

25 (v) ~~public libraries;~~

26 (vi) ~~rural fire districts and other entities providing fire protection under Title 7, chapter 33;~~

27 (vii) ~~special districts created pursuant to Title 7, chapter 11, part 10; and~~

28 (viii) ~~subject to subsection (2), federally recognized Indian tribes in the state if the property is located~~

1 entirely within the exterior boundaries of the reservation of the tribe that owns the property and the property is
2 used exclusively by the tribe for essential government services. Essential government services are tribal
3 government administration, fire, police, public health, education, recreation, sewer, water, pollution control,
4 public transit, and public parks and recreational facilities.

5 (b) — buildings and furnishings in the buildings that are owned by a church and used for actual
6 religious worship or for residences of the clergy, not to exceed one residence for each member of the clergy,
7 together with the land that the buildings occupy and adjacent land reasonably necessary for convenient use of
8 the buildings, which must be identified in the application, and all land and improvements used for educational or
9 youth recreational activities if the facilities are generally available for use by the general public but may not
10 exceed 15 acres for a church or 1 acre for a clergy residence after subtracting any area required by zoning,
11 building codes, or subdivision requirements;

12 (c) — land and improvements upon the land, not to exceed 15 acres, owned by a federally
13 recognized Indian tribe when the land has been set aside by tribal resolution and designated as sacred land to
14 be used exclusively for religious purposes;

15 (d) — property owned and used exclusively for agricultural and horticultural societies not operated for
16 gain or profit;

17 (e) — property, not to exceed 80 acres, which must be legally described in the application for the
18 exemption, used exclusively for educational purposes, including dormitories and food service buildings for the
19 use of students in attendance and other structures necessary for the operation and maintenance of an
20 educational institution that:

21 (i) — is not operated for gain or profit;

22 (ii) — has an attendance policy; and

23 (iii) — has a definable curriculum with systematic instruction;

24 (f) — property, of any acreage, owned by a tribal corporation created for the sole purpose of
25 establishing schools, colleges, and universities if the property meets the requirements of subsection (1)(e);

26 (g) — property used exclusively for nonprofit health care facilities, as defined in 50-5-101, licensed by
27 the department of public health and human services and organized under Title 35, chapter 2 or 3. A health care
28 facility that is not licensed by the department of public health and human services and organized under Title 35,

1 ~~chapter 2 or 3, is not exempt.~~

2 ~~(h) — property that is:~~

3 ~~(i) — (A) owned and held by an association or corporation organized under Title 35, chapter 2, 3, 20,~~
4 ~~or 21; or~~

5 ~~(B) — owned by a federally recognized Indian tribe within the state and set aside by tribal resolution;~~
6 ~~and~~

7 ~~(ii) — devoted exclusively to use in connection with a cemetery or cemeteries for which a permanent~~
8 ~~care and improvement fund has been established as provided for in Title 35, chapter 20, part 3; and~~

9 ~~(iii) — not maintained and not operated for gain or profit;~~

10 ~~(i) — subject to subsection (2), property that is owned or property that is leased from a federal, state,~~
11 ~~or local governmental entity by institutions of purely public charity if the property is directly used for purely~~
12 ~~public charitable purposes;~~

13 ~~(j) — evidence of debt secured by mortgages of record upon real or personal property in the state of~~
14 ~~Montana;~~

15 ~~(k) — public museums, art galleries, zoos, and observatories that are not operated for gain or profit;~~

16 ~~(l) — motor vehicles, land, fixtures, buildings, and improvements owned by a cooperative association~~
17 ~~or nonprofit corporation organized to furnish potable water to its members or customers for uses other than the~~
18 ~~irrigation of agricultural land;~~

19 ~~(m) — the right of entry that is a property right reserved in land or received by mesne conveyance~~
20 ~~(exclusive of leasehold interests), devise, or succession to enter land with a surface title that is held by another~~
21 ~~to explore, prospect, or dig for oil, gas, coal, or minerals;~~

22 ~~(n) — (i) property that is owned and used by a corporation or association organized and operated~~
23 ~~exclusively for the care of persons with developmental disabilities, persons with mental illness, or persons with~~
24 ~~physical or mental impairments that constitute or result in substantial impediments to employment and that is~~
25 ~~not operated for gain or profit; and~~

26 ~~(ii) — subject to subsection (2)(e), property that is owned and used by an organization owning and~~
27 ~~operating facilities that are for the care of the retired, aged, or chronically ill and that are not operated for gain or~~
28 ~~profit;~~

1 (e) — property owned by a nonprofit corporation that is organized to provide facilities primarily for
2 training and practice for or competition in international sports and athletic events and that is not held or used for
3 private or corporate gain or profit. For purposes of this subsection (1)(e), "nonprofit corporation" means an
4 organization that is exempt from taxation under section 501(c) of the Internal Revenue Code and incorporated
5 and admitted under the Montana Nonprofit Corporation Act.

6 (p) — property rented or leased to a municipality or taxing unit for less than \$100 a year and that is
7 used for public park, recreation, or landscape beautification purposes. For the purposes of this subsection
8 (1)(p), "property" includes land but does not include buildings. The exemption must be applied for by the
9 municipality or taxing unit, and not more than 10 acres within the municipality or taxing unit may be exempted.

10 (2) — (a) (i) For the purposes of tribal property under subsection (1)(a)(viii), the property subject to
11 exemption may not be:

12 (A) — operated for gain or profit;

13 (B) — held under contract to operate, lease, or sell by a taxable individual;

14 (C) — used or possessed exclusively by a taxable individual or entity; or

15 (D) — held by a tribal corporation except for educational purposes as provided in subsection (1)(f).

16 (ii) — For the purposes of parks and recreational facilities under subsection (1)(a)(viii), the property
17 must be:

18 (A) — set aside by tribal resolution and designated as park land, not to exceed 640 acres, or be
19 designated as a recreational facility; and

20 (B) — open to the general public.

21 (b) — For the purposes of subsection (1)(b), the term "clergy" means, as recognized under the
22 federal Internal Revenue Code:

23 (i) — an ordained minister, priest, or rabbi;

24 (ii) — a commissioned or licensed minister of a church or church denomination that ordains ministers
25 if the person has the authority to perform substantially all the religious duties of the church or denomination;

26 (iii) — a member of a religious order who has taken a vow of poverty; or

27 (iv) — a Christian Science practitioner.

28 (c) — For the purposes of subsection (1)(i):

1 (i) ~~the term "institutions of purely public charity" includes any organization that meets the following~~
2 ~~requirements:~~

3 (A) ~~The organization offers its charitable goods or services to persons without regard to race,~~
4 ~~religion, creed, or gender and qualifies as a tax-exempt organization under the provisions of section 501(c)(3),~~
5 ~~Internal Revenue Code, as amended.~~

6 (B) ~~The organization accomplishes its activities through absolute gratuity or grants. However, the~~
7 ~~organization may solicit or raise funds by the sale of merchandise, memberships, or tickets to public~~
8 ~~performances or entertainment or by other similar types of fundraising activities.~~

9 (ii) ~~agricultural property owned by a purely public charity is not exempt if the agricultural property is~~
10 ~~used by the charity to produce unrelated business taxable income as that term is defined in section 512 of the~~
11 ~~Internal Revenue Code, 26 U.S.C. 512. A public charity claiming an exemption for agricultural property shall file~~
12 ~~annually with the department a copy of its federal tax return reporting any unrelated business taxable income~~
13 ~~received by the charity during the tax year, together with a statement indicating whether the exempt property~~
14 ~~was used to generate any unrelated business taxable income.~~

15 (iii) ~~up to 15 acres of property owned by a purely public charity is exempt at the time of its purchase~~
16 ~~even if the property must be improved before it can directly be used for its intended charitable purpose. If the~~
17 ~~property is not directly used for the charitable purpose within 8 years of receiving an exemption under this~~
18 ~~section or if the property is sold or transferred before it entered direct charitable use, the exemption is revoked~~
19 ~~and the property is taxable. In addition to taxes due for the first year that the property becomes taxable, the~~
20 ~~owner of the property shall pay an amount equal to the amount of the tax due that year times the number of~~
21 ~~years that the property was tax-exempt under this section. The amount due is a lien upon the property and~~
22 ~~when collected must be distributed by the treasurer to funds and accounts in the same ratio as property tax~~
23 ~~collected on the property is distributed. At the time the exemption is granted, the department shall file a notice~~
24 ~~with the clerk and recorder in the county in which the property is located. The notice must indicate that an~~
25 ~~exemption pursuant to this section has been granted. The notice must describe the penalty for default under~~
26 ~~this section and must specify that a default under this section will create a lien on the property by operation of~~
27 ~~law. The notice must be on a form prescribed by the department.~~

28 (iv) ~~not more than 160 acres may be exempted by a purely public charity under any exemption~~

1 originally applied for after December 31, 2004. An application for exemption under this section must contain a
2 legal description of the property for which the exemption is requested.

3 (d) ~~For the purposes of subsection (1)(k), the term "public museums, art galleries, zoos, and~~
4 ~~observatories" means governmental entities or nonprofit organizations whose principal purpose is to hold~~
5 ~~property for public display or for use as a museum, art gallery, zoo, or observatory. The exempt property~~
6 ~~includes all real and personal property owned by the public museum, art gallery, zoo, or observatory that is~~
7 ~~reasonably necessary for use in connection with the public display or observatory use. Unless the property is~~
8 ~~leased for a profit to a governmental entity or nonprofit organization by an individual or for-profit organization,~~
9 ~~real and personal property owned by other persons is exempt if it is:~~

10 (i) ~~actually used by the governmental entity or nonprofit organization as a part of its public display;~~

11 (ii) ~~held for future display; or~~

12 (iii) ~~used to house or store a public display.~~

13 (e) ~~For the purposes of facilities for the care of the retired, aged, or chronically ill under subsection~~
14 ~~(1)(n)(ii), the terms "retired" and "aged" mean an individual who satisfies the age is 62 years of age or older and~~
15 ~~has a gross household income limitations of 15-30-2338 OF LESS THAN \$45,000 . The property owner shall verify~~
16 ~~age and gross household income requirements on a form prescribed by the department. Applicants are subject~~
17 ~~to the false swearing penalties established in 45-7-202 . "~~

19 **SECTION 5. SECTION 15-6-240, MCA, IS AMENDED TO READ:**

20 **"15-6-240. Intangible land value property exemption -- application procedure.** (1) There is an
21 intangible land value assistance program that provides graduated levels of property tax exemptions to assist
22 owners of primary residences with land values that are disproportionate to the value of a primary residence and
23 improvements. To be eligible for the exemption, applicants must meet the requirements of this section.

24 (2) If the total appraised value of the land is equal to or less than 150% of the appraised value of
25 the primary residence and improvements situated on the land, then the land exemption provided in this section
26 does not apply.

27 (3) Subject to subsection ~~(6)~~ (7), if the total appraised value of the land is greater than 150% of the
28 appraised value of the primary residence and improvements situated on the land, then the land is valued at

1 150% of the appraised value of the primary residence and improvements situated on the land, subject to the
2 minimum equalization of value requirement in subsection (4), and the remainder of the land value is exempt
3 from taxation.

4 (4) If the calculation in subsection (3) creates a land value that is less than the statewide average
5 value of land, then the value of the land may not be reduced in an amount that is less than the statewide
6 average value of land multiplied by the acreage of land for the subject property.

7 (5) This section does not provide an exemption for the primary residence and improvements
8 situated on the land.

9 (6) Property eligible for the exemption provided for in this section is not eligible for the property tax
10 assistance programs provided for in Title 15, chapter 6, part 3.

11 (7) (a) A claim for assistance must be filed by March 1 of the tax year for which the exemption is
12 sought, on an application form provided by the department. After an exemption is approved, the applicant
13 remains eligible for the exemption for the remainder of the 2-year valuation cycle provided for in 15-7-111 as
14 long as the property is continually used as a primary residence by the applicant. An applicant who does not
15 apply for assistance during the first year of the valuation cycle may apply during the second year of the cycle.

16 (b) The application form must contain:

17 (i) an affirmation that the applicant owns and maintains the land and improvements as the primary
18 residence;

19 (ii) an affirmation that the land has been owned by the applicant or a family member of the
20 applicant within the third degree of consanguinity for at least 30 consecutive years; and

21 (iii) any other information required by the department that is relevant to the applicant's eligibility.

22 (c) When providing information to the department for qualification under this section, applicants
23 are subject to the false swearing penalties established in 45-7-202.

24 (d) The department may investigate the information provided in an application and an applicant's
25 continued eligibility.

26 (e) The department may request applicant verification of the primary residence.

27 (8) As used in this section the following definitions apply:

28 (a) "Land" means:

1 (i) parcels of land or lots of not more than 5 acres under single ownership that support the primary
2 residential improvements. The term does not include parcels of land or lots that do not support the primary
3 residential improvements, regardless of whether those parcels or lots are contiguous with or adjacent to the
4 primary residential property.

5 (ii) subject to the limitations in subsection ~~(7)(a)(i)~~ (8)(a)(i), separately assessed land on which a
6 mobile or manufactured home is located, but only if the mobile or manufactured home and the land are both
7 owned by the applicant.

8 (b) "Primary residence" means a single-family dwelling:

9 (i) in which an applicant can demonstrate the applicant lived for at least 7 months of the year for
10 which benefits are claimed;

11 (ii) that is the only residence for which the land exemption claimed in this section is claimed by the
12 applicant; and

13 (iii) that is owned or under contract for deed by the applicant.

14 (c) "Single-family dwelling" means a residential dwelling, manufactured home, trailer, or mobile
15 home. The term does not include a condominium unit or a unit of a multiple-unit dwelling.

16 (d) "Statewide average value of land" is a value calculated by the department that is equal to the
17 statewide average market value of 1 acre of class four real property described in 15-6-134(1)(a) through (1)(d)."

18

19 **SECTION 6. SECTION 15-6-302, MCA, IS AMENDED TO READ:**

20 **"15-6-302. Property tax assistance -- rulemaking.** (1) The requirements of this section must be met
21 for a taxpayer to qualify for property tax assistance under 15-6-305 or 15-6-311.

22 (2) For the property tax assistance programs provided for in 15-6-305 and 15-6-311, the residential
23 real property must be owned by the applicant or under contract for deed and be the primary residence as
24 defined in 15-6-301. The department shall make rules specifying the indicators used for determining whether a
25 residence is a primary residence for purposes of property tax assistance programs.

26 (3) An applicant's qualifying income, as defined in 15-6-301, may not exceed the threshold
27 established in 15-6-305 or 15-6-311 or in rules established pursuant to those sections.

28 (4) (a) A claim for assistance must be submitted on a form prescribed by the department.

(i) a notice of the availability of ~~all the property tax assistance programs available to property taxpayers, including the intangible land value assistance program provided for in 15-6-240, the property tax assistance programs provided for in Title 15, chapter 6, part 3, and the residential property tax credit for the elderly provided for in 15-30-2337 through 15-30-2341~~ ALL THE PROPERTY TAX ASSISTANCE PROGRAMS AVAILABLE TO PROPERTY TAXPAYERS, INCLUDING THE INTANGIBLE LAND VALUE ASSISTANCE PROGRAM PROVIDED FOR IN 15-6-240, THE PROPERTY TAX ASSISTANCE PROGRAMS PROVIDED FOR IN TITLE 15, CHAPTER 6, PART 3, THE RESIDENTIAL PROPERTY TAX CREDIT FOR THE ELDERLY PROVIDED FOR IN 15-30-2337 THROUGH 15-30-2341, AND the property tax and rent-equivalent property tax circuit breaker credit provided for in [sections 1 through 4];

- (ii) the total amount of mills levied against the property in the prior year;
